Research leadership:

2021 – 2024: Principal Investigator of 'Food Security and Increased Market Regulation in the Global South (FAIM)'.

FAIM investigates how market economic regulation in developing countries affects the poorest groups in society, using food security as measure. Little systematic academic research exists on the relation between market economic regulation and the impact on the poorest groups in developing countries. FAIM challenges current state of the art by focusing on food security over economic growth in examining the effects of market economic regulation. The project applies mixed methods cutting across law, sociology and economics, and it adopts an innovative angle by following the supply chain of two selected key staple crops (maize and cassava) across rural and urban sites in Tanzania. The objective is to improve our understanding of how different market economic regulatory measures affect the poorest in society. Henrik Hansen, Professor of Development Economics, is co-PI. Two PhD researchers (coming from economics and development studies) will begin work on 1 April 2021 and will both be co-supervised by Hansen and Broberg.

2018 – 2021: Principal Investigator of 'Preparing for a World Beyond Repair: Legal Responses to Foreseeable Climate Tragedy (ReFleCT)'.

ReFleCT examines a remarkable shift in the international legal framework on climate change. Emerging legal phenomena are moving away from traditional mitigation and adaptation efforts towards a legal framework that is closer to reparation than it is to prevention or repair. ReFleCT examines these phenomena to contribute new academic insight into whether this new approach will deliver solutions to the States and individuals most vulnerable to climate change. The funding together with co-funding has allowed me to employ and supervise a PhD researcher to provide a human rights perspective towards the climate change concept of 'loss and damage' as well as a postdoc to examine the legal aspects of climate change induced migration ('climate refugees').

2013 – 2017: Principal Investigator of '*Changing Disasters*' financed by University of Copenhagen's Excellence Programme for Interdisciplinary Research (approx. EUR 2.5 million + co-funding).

Changing Disasters involved a large number of researchers – both employed directly by Changing Disasters and on secondment from different UCPH faculties – from law, theology, science, health, the humanities and the social sciences. The project aimed to explore both how disasters are shaped by societies and how disasters shape societies. Therefore, the researchers involved in the project investigated the social, political, technical and cultural aspects of how societies interpret and respond to disasters, and they described changes in society initiated by these catastrophic events. My own research focus as part of the project was upon the interaction between disasters and societies in the Global South.
